### **Manuscript submission:**

Before the submission, authors are required to ensure that manuscripts have been written well in English (UK) or Bahasa (Indonesian) and the citations should conform as closely as possible to the McGill Law Journal (Canadian Guide to Uniform Legal Citation). The Journal will review manuscripts which should be between 7,000-15,000 words (Articles), 3,000-7,000 (Case Notes), and 1,000-2,500 (Book Reviews). All articles published in this Journal are processed under a blind peer-review of the editorial board. The board and reviewers are legal scholars with specific expertise in accordance with focus and scope of the Journal. The peer-reviewed process and decision on the publication of manuscripts will normally be completed within three months since the day of submitting papers.
